No. PER(AR)74/2025/1 - In exercise of the powers conferred by the proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Meghalaya is pleased to make the following Regulations further to amend the Meghalaya Public Service Commission (Limitation of Functions) Regulations, 1972, namely:-

1. Short title and commencement.

- (1) These Regulations may be called the Meghalaya Public Service Commission (Limitation of Functions) (Amendment) Regulations, 2026.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. Amendment of Regulation 3.

In Regulation 3 of the Meghalaya Public Service Commission (Limitation of Functions) Regulations, 1972, sub-regulation (f) shall be omitted.
